

Excerpt: . . . 3. This conclusion makes it unnecessary for us to express any opinion on the matters of fact which were found by the Board of Contract Adjustment. 4. Section 148 of the Judicial Code provides that: When any claim or matter is pending in any of the executive departments which involves controverted questions of fact or law, the head of such department may transmit the same, with the vouchers, papers, documents, and proofs pertaining thereto, to the Court of Claims, and the same shall be there proceeded in under such rules as the court may adopt. 5. Inasmuch as the question involved in this case applies equally to a large number of cases pending before the Secretary of War, it seems to us to be such a case as might well be submitted to the Court of Claims under this provision of the Judicial Code. 6. It is accordingly recommended that if such course is deemed advisable this claim be transmitted to the Court of Claims under the provisions of the statute above referred to, and in case it is not so transmitted that the decision of the Board of Contract Adjustment be affirmed on the single ground that the case is not one in which the Secretary of War would be justified in setting aside the supplemental contract.
